Are you looking for help with an eviction?

Although our office is closed during our move, our eviction clinics are still operating. Colorado Legal Services (CLS) staff offers free eviction clinics for renters with a court summons for an eviction.

NOTE: The clinics are **only available to help people on or before the day of their court summons.** Your summons may look something like this:
